TERMS & CONDITIONS

SCHEDULE

Promoter:	Burswood Nominees Limited (ABN 24 078 250 307) as trustee for The Burswood Property Trust trading as Crown Perth, Great Eastern Highway Burswood, Western Australia 6100.
Entrants (who can enter?):	Western Australian Residents aged eighteen (18) years or over who are not excluded or prohibited from entering the Promoter's property or any Crown property for any reason.
	All Crown Rewards Members who are not excluded or prohibited from entering the Promoter's property or any Crown property for any reason.
	Entrants who have not been disqualified from any prior promotion, competition or offer for any reason by the Promoter.
	4. Entrants who are not a spouse, partner, sibling, parent or child of an Executive team member of the Promoter.
	Entrants who have provided or entered their personal information or contact details correctly.

Participating Venue(s)	Crown Perth
Promotion Period:	Friday 29 November 2024 to Saturday 28 December 2024, with each Friday and Saturday during the Promotional Period being a Promotional Day.
	All times recorded throughout these Terms & Conditions are in Australian Western Standard Time.
Entry Mechanic:	On the Promotional Day during the Promotion Period, Entrants will receive one (1) entry for every fifty (50) Crown Rewards Points earned at Crown Perth when dining or playing at Crown Perth (Entry), up to a maximum of twenty (20) Entries per Day. Points earned from Hotel stays or retail outlets during the Promotional Period are not eligible.
	Entrants must visit a Voucher Issuance Kiosk (VIK) each Promotional Day to register their entries into the virtual draws.
	To participate in the prize draws at 4pm, 5pm and 6pm (first session) entrants will need to register from 3pm to 5.55pm.
	To participate in the prize draws at 8pm, 9pm and 10pm (second session) entrants will need to register from 7pm to 9.55pm.

Registration is required to enter the draws. Entrants will need to visit a VIK to claim any additional entries earned in the same session after the initial registration. Entrants who do not visit a VIK to register their participation during this period will not be considered an eligible entrant for the promotion.

For avoidance of doubt, if entrants register by 4pm, they will be eligible for both the 4pm, 5pm and 6pm prize draws, and all entries earned up to 4pm will be entered into all the prize draws. Entrants will be required to register any additional entries earned after the 4pm prize draws for them to be eligible for the 5pm and 6pm prize draws.

Entries are only eligible for the relevant promotional day. Entries are automatically added until the time of draw.

There will be no entry forms printed.

In the event of any technical issues experienced during any Day, the Promoter reserves the right to alter the Entry mechanics, including but not limited to the process by which Entries are earned, which will be announced within the Promoter's venue during the relevant Promotional Day. Upon such technical issues being rectified the Entry mechanism detailed above shall resume. Crown Rewards points earned via Gaming activity must be earned via Active Play. Active Play means the entrant must have earned Crown Rewards points by actively gaming during the Promotional Period. Active Play does not include any points earned passively or without active gaming or betting.

Prize Draw(s):

At each Prize Draw, the first valid entry drawn from the entries received for the Prize Draw on the Day (**Drawn Winner**) will have the opportunity to play the Promotional Game.

Entries received in respect of a Prize Draw will not roll over to subsequent Prize Draws on subsequent Days of the Promotion Period. Winning entries from a Prize Draw will not be placed back into the Promotion barrel for subsequent Prize Draws during the Promotion Period.

Promotional Game

The Promotional Game will take place immediately after each respective Prize Draw on the main Casino Stage.

Gift Box Selection:

Each Draw Winner will have the opportunity to select one (1) gift box from a set of six (6) boxes displayed on a digital screen at the main Casino Stage. To select, the Draw Winner will press a corresponding button on stage. Each gift box contains a hidden cash value with prizes ranging from a minimum of \$200 to a maximum of \$500. Once a box is selected, no changes are permitted.

Multiplier Wheel Spin:

After the gift box selection, the Draw Winner will spin a 13-panel Multiplier Wheel, which determines the multiplier applied to the cash prize selected. The wheel features the following multipliers:

- 2X
- 3X
- 5X

The final prize amount for each winner will be determined by applying the selected multiplier to the initial cash prize.

All amounts and decision made by the Promoter's representative are final. In the event of any technical issues experienced on any Promotional Day, the Promoter reserves the right to alter the mechanic of the Promotional Game which will be announced within the Promoter's venue on the relevant Promotional Day. However, in the event the Promotional Game cannot operate due to technical issues, the Promoter will award a default prize of \$400 to the Participant.
Prize(s)	Each Participant who participates in the Promotional Game may win a minimum of \$400 or a maximum of \$2,500. All Draw Winners must collect their Prize Letter (upon presenting Acceptable Identification to the satisfaction of the Promoter) from the main Casino Stage upon conclusion of the Promotional Game.

GENERAL TERMS & CONDITIONS

- m) **Disputes**: The Promoter's decision in connection with any aspect of this Promotion will be binding and final on every Entrant.
